INTRODUCTION: Until 1915, the creation and maintenance of roads within any particular NC county fell under the jurisdiction of that county's court system. Road Records is the category of records at NC Archives, within the County Records Series, which preserves the surviving loose pieces of paper relative to the formation and maintenance of a county's road system. In counties with surviving court minutes, reference to creation and maintenance of that county's roads might be found also in the county court minute books.

According to NC Archives: "The first six volumes of Granville County Court Minutes, Court of Pleas & Quarter Sessions, have been missing since 1895. These minutes were abstracted before they disappeared. The abstracts are available on microfilm (Z.4.13) [at NC Archives]. A published edition, entitled History and Genealogies of Old Granville County, North Carolina, 1746-1800 [by Thomas McAdory Owen] is located in the Genealogy Section of the State Library." The published edition is available also in the North Carolina Room at R. H. Thornton Library, Oxford, NC.

Due to missing Granville County court minute books, the surviving Granville County Road Records for the colonial time period are especially valuable. The earliest dated extant Granville County Road Records begin in the year 1749, and include references to roads not noted by Dr. Owen in his abstracts.

Included in <u>Road Records</u> might be: (1.) Petitions [for laying out, constructing, altering, or repairing roads; the petitioners are usually those "freeholders" [land owners] living in the neighborhood of that particular road]; (2.) Orders by the Court [which might include appointment of men to construct or maintain a road and appointment of one, to act as overseer]; (3.) Reports [by juries or commissioners appointed to construct or maintain a road, describing the matter under consideration]; (4.) Other miscellaneous records pertaining to the creation or upkeep of the county's roads might be found in <u>Road Records</u>.

Granvillians in Macon County, NC

The following is an abstract of selected entries from the 1860 Census of Macon County, NC. The census record provided a space for "place of birth", meant to signify state or country of birth. The census taker for Macon County in this year, John Ingram, went a step farther and, when the person was born in North Carolina, he supplied the county of birth. All entries that show a member of the household with a Granville County birthplace have been extracted. Granville Biography

ESTABLISHING JOHN & MOURNING HUNT IN GRANVILLE COUNTY, NC

There are apparently three HUNT lines in colonial Granville County, North Carolina: Henry & Agnes Hunt family; Memucan & Mary/Polly Wade Hunt family; John & Mourning Hunt family. To date, no relationships among these families have been proved. The particular focus of the following is the family of John and Mourning Hunt. Researchers are currently investigating the other Hunt groups in Granville County.

The popular name John is used by all Hunt families in colonial Granville County. Therefore, Mourning Hunt is pivotal to establishing the identity of the family of John and Mourning Hunt. Proof that Mourning Hunt was married to John Hunt is established by a Granville County, North Carolina marriage contract signed by Mourning's next husband William Hicks, dated 25 June 1778.1 This contract states that the marriage of Mourning and William Hicks has taken place; that Mourning was formerly the wife of John Hunt, deceased; and that William Hicks relinquishes all claim to the estate owned by Mourning when they married, ie: 190 acres of land and seven slaves: Glasgow, Dinah, Silvie, Emra, Patt, and Charity. Hicks names the children of "John Hunt Deceased," and Mourning Hunt: [a] John Hunt; [b] George Hunt; [c] Samuel Hunt; [d] James Hunt; [e] Judith Hunt.

The first mentions of Mourning Hunt in the records of Granville County, North Carolina are in the year 1768. On 1 November 1768, Mourning Hunt purchased, in her own right, a tract of land on both sides of Fishing Creek.² In addition, thorough examination of extant Granville County tax lists, 1746-1768, reveals that Mourning Hunt is listed on the county's tax list for the first time in 1768.³ It is unlikely a married woman would be named on the tax list as head-of-household instead of her husband if her husband were living. Married women were forbidden by law to own property in their own right, unless permitted by marriage contract. No such marriage contract between John and Mourning Hunt has been found. As Mourning Hunt is acting in her own right, we may deduce that John Hunt husband of Mourning Hunt was deceased by 1768.

On the 1768 tax list, Mourning Hunt listed [son] George Hunt and two slaves: Glasgow and Dinah.⁴ On the same 1768 tax district list,⁵ only two entries separate, the tax for [Mourning's son] John Hunt was listed by his uncle,⁶ James Hunt. Thus in 1768, Mourning Hunt had two sons of/over NC's then taxable age of sixteen. That the John Hunt whose 1768 taxes were paid by James Hunt is the same John, son of Mourning Hunt, is proved by the following chain of evidence:

- <u>a.</u> Granville County, NC, marriage bond dated 5 August 1771; John Hunt married Frances Penn; bondsman was James Hunt. NC Archives, Raleigh, NC.
- **b.** Granville County, NC, deed of gift dated 19 August 1772, proved August Court 1772, from James Hunt to "Nephew John Hunt," land on both sides of great Island Creek and being the land John Hunt currently lives on. Deed Book K, page 1; Register of Deeds Office, Courthouse, Oxford, NC.
- $\underline{\mathbf{c}}$. Granville County, NC, deed of sale dated 17 December 1772, from James Hunt and wife Sarah and John Hunt and wife Frances to John Penn; 1602 Acres, "all the lands belonging to the said James Hunt and John

Hunt ... on both sides of Great Island Creek." Deed Book K, page 172; Register of Deeds Office, Courthouse, Oxford, NC.

- **d.** Granville County, NC, marriage contract dated 25 June 1778, signed by William Hicks; release of estate to the named children of Mourning Hunt and her husband John Hunt, Deceased, by William Hicks after his marriage to Mourning Hunt. Will Book 1, pages 185-186; Clerk of Court's Office, Courthouse, Oxford, NC.
- e. Granville County, NC, will of John Hunt, Sr.* dated January 1816, proved August Court 1818; names wife Frances; and mother, Mourning Hicks. Original will in Clerk of Court's Office, Courthouse, Oxford, NC.

NOTE: The designation "Senior" only indicates that there are 2 or more men of the same name in the same county, and the man called "Senior" was the elder. The term "Senior" does not necessarily indicate a relationship between/among men with the same name and may apply variously to different men at different times. For example, a man once known as "John Hunt, Jr." might be called "John Hunt Sr." after one [older] "John Hunt" died or moved away.

As stated, Mourning Hunt had two taxable slaves and two taxable sons in 1768. There is no known evidence or family tradition indicating the two sons were twins. Therefore, if the family resided in Granville County prior to 1768, there should be evidence of them on earlier Granville County tax lists. There is no mention of Mourning Hunt, or slaves Glasgow or Dinah, or sons John or George on the Granville County, NC, 1766 or 1767 tax lists.

There is a John Hunt named on the tax list of Granville County for 1767.8 However, that John Hunt does not own slaves nor list another male of taxable age. In addition, that particular John Hunt apparently is listed again on the 1768 tax list, As Mourning Hunt, and her son John, are also listed on the 1768 tax list, the John Hunt named on both the 1767 and 1768 Granville County tax lists is neither the husband nor the son of Mourning Hunt.

As 1768 is the earliest that Mourning Hunt and her family may be established in the records of Granville County, the conclusion may be drawn that widow Mourning Hunt moved to Granville County in 1768, possibly to be near her husband's childless¹¹ brother, James Hunt. Lending support to the above hypothesis is the deed, K:1, mentioned as #(b) in the previously given chain of evidence. In addition to paying taxes on Mourning's son John, James Hunt executed this deed of gift to his "nephew John Hunt" dated 19 August 1772; giving 400 acres to nephew John Hunt "for love and affection" [standard deed of gift wordage] and "for his advancement in the World." The deed further states the tract of land was known by the name "Poplar Ridge" and that John Hunt already resided on the tract.

Following are the writer's abstracts of all property transactions relating to Mourning Hunt in Granville County:

- <u>DB H:469-470</u> 1 November 1768; Malichy REAVES of Granville County to Mourning HUNT of same; 50 pounds: 100 Acres; on both sides of Fishing Creek, beginning on the North side of Fishing Creek ... south 160 poles ... West 190 poles ... along a line of marked Trees on the East side of New Road ... East to the beginning; Malichy REEVES (signature); Witnesses: John TATOM; Abrm. TATOM; Acknowledged by Malichy REEVES, November Court 1768.
- <u>DB L:213/214</u> 1 December 1777; Mourning HUNT of Granville County to Robert HESTER of same; 50 pounds: 100 Acres; on both sides of Fishing Creek, beginning on the North side of Fishing Creek ... South 160 poles ... West 190 poles ... along a line of marked trees on the East side of the New Road ... East to the beginning: Mourning HUNT (her mark);

Witnesses: James CURRIN, Benjamin HESTER; Proved by James CURRIN, February Court 1778.

- <u>DB L:194-195</u> 3 February 1778; Thomas NORMAN of Granville County to Mourning HUNT of same; 150 pounds; 190 Acres; beginning at Lenhenly BULLOCKS Corner ... North 160 poles ... West 170 poles ... South 190 poles ... East 170 poles to the beginning; Thos. NORMAN (signature); Witnesses: Sherwood HARRIS, John WASHINGTON; Acknowledged by Thomas NORMAN, February Court, 1778.

On 27 May 1778, William Hicks signed a marriage bond to marry Mourning Hunt.¹² The previously cited marriage contract signed by William Hicks after his marriage to Mourning Hunt is dated 25 June 1778. Therefore, the marriage of Mourning Hunt and William Hicks occurred some time between 27 May 1778 and 25 June 1778. Marriage bonds were taken out prior to marriage, so technically a marriage bond date shows intent to marry. It is accepted practice to cite the marriage bond date as the date of marriage if actual marriage date is not known.

Mourning Hicks' date of death, year of birth, and church membership are documented in a typescript of Presbyterian Session Book, Providence Meeting House, entry dated 21 October 1823: "This evening Mrs. M. Hicks departed this life after 6 days illness ... She was upwards of 90 years old, yet had rode (sic) on horseback 7 or 8 miles about a week before her death. She was probably the oldest Presbyterian Church member in this county." ¹³

Corroborating that the above "Mrs. M. Hicks" is "Mourning Hunt Hicks," is an excerpt from a typescript titled: <u>Taken from John Penn Hunt's Book of January 30th 1845</u>, copied by Edna Hilliard White Wood, which lists: "Mourning Hicks departed this Life, October 22nd, 1823." There is one day's discrepancy in the two cited accounts, therefore, this writer will cite the date of death for Mourning Hunt Hicks as 21/22 October 1823.

- NOTE: Although the typescript identifies the original book recording Hunt family dates as belonging to John Penn Hunt, the record actually appears to have been started by the father of John Penn Hunt, John Hunt, son of Mourning Hunt Hicks. Among evidence that John Hunt started the written record are the following entries included in a listing of deaths:
 - (a). "Brother Samuel Hunt" John Penn Hunt did not have a brother named Samuel. John Hunt did have a brother named Samuel, named in marriage contract between William Hicks & Mourning Hunt (see above citation #1). In addition, NC Archives, "Granville County Estate Record of Samuel Hunt," corroborates the date of death of John Hunt's brother, Samuel, with the death listing of "Brother Samuel Hunt" in above cited typescript of Hunt family.
 - (b). "Father William Hicks" per cited marriage contract between William Hicks & Morning Hunt Hicks [see above citation #1]: William Hicks was stepfather of John Hunt, not John Penn Hunt.

Ultimately, the book containing dates of births, marriages, and deaths of this Hunt family did belong to John Penn Hunt and therefore will be cited as such.

Granville County Apprentice Bonds

(first in series)

The following was transcribed from a microfilm copy (C.044-10001) *Granville County Apprentice Bonds*, 1802 - 1867, housed at the Richard H. Thornton Library, Oxford, NC. It was verified against the original *Granville County Apprentice Docket*, (CR 044 101.1) housed at the North Carolina State Archives.

The collection of loose apprentice bonds at the North Carolina Archives is extensive and is contained in two fibredex boxes. The *Granville County Apprentice Docket* is a book in which the schedule of those cases that actually went to court for disposition is listed. The only Apprentice Docket extant begins in 1802, though the files of loose Apprentice Bonds begin in 1749. Actual page breaks are denoted by center bars. Ditto marks were used extensively, but do not appear to imply that the information was the same as the above, but rather placed in the space to show that the correct information was not known and that the space was not inadvertantly left blank. In some cases, the age of the child appears to be the age on that particular court day; others seem to be a date of birth.

"Thomas Clingman JOYNER of Franklinton and Margaret Camilla LYNCH of Oxford did indeed marry. Margaret Camilla was the first born (1857) to Thomas Moses LYNCH and Cecelia Elizabeth DORSEY. Thomas LYNCH was an Oxford jeweler. On the night of 22 November 1881, on his way from work, he was murdered ... [later the murderers were] hung in a tree on Cherry Hill which was near the scene of the murder. This story was told by Francis B. HAYS on 2 January 1917...

Thomas Clingman JOYNER was born in Franklinton in 1848 and was the youngest son of William Henry JOYNER and his wife Julia Henderson TIMBERLAKE. T. C. JOYNER owned a drug store in Franklinton where he started the business in 1876. His sons continued in this business until 1937.

Thomas and Margaret had seven children ... Thomas Clingman JOYNER died in 1913, and his wife, Margaret, died in 1908."

and Miss Jennie GREGORY, my four new and dear friends, I address my letter relative to my dear deceased Neppie. We arrived in Franklinton 2 o'clock A.M., but did not get home until 4 o'clock, the next day. The Telegraphic dispatch, I suppose was not received in Raleigh as we never heard any thing from it. We had to write home from Franklinton for the carriage, and to Louisburg (ten miles) [sic] for the hearse.

My dear friends it is needless for me to attempt a description of the scene which followed my arrival. Suffice it to say I found them all deeply distressed, especially my poor mother who seems as yet unwilling to give up her darling child without seeing her once more. She is in bed, and looks very very feeble. I am afraid the blow will prove too much for her though [I sin]cerely pray that our GCGS, 1746 - '95

kind heavenly Father may give us all sufficient Grace to bear up under any affliction he may see fit in His Great Wisdom to Send upon us. The death of Neppie has indeed cast a dark dark [sic] Shadow over this family & neighborhood; but may the Good Lord help us to say with "Job of Old" Lord gave, and, the Lord hath taken away, Blessed be the name of the Lord. Dear Neppie was very much beloved by all who knew and when told she was dead seemed very much grieved, and some of her married lady friends even wept aloud they were so shocked at her sudden death. Her funeral was preached by Mr. RICAUD. His text you can find in the 34th Psalm. "Many are the afflictions of the righteous; but the Lord delivereth him out of them all." Mr. RICAUD boarded in the college at Louisburg at the same time she died and knew her well, She there made a profession of religion during his revival - he alluded to this in his sermon, and spoke of her as being a lovely girl, dispensing joy and sunshine wherever she went. Her funeral was very generally attended. She was buried at Mrs. MITCHELL'S (my sister) two miles from us on Thursday 28th. She looked quite natural and had that same sweet smile resting on her countenance. All the family wished to know who dressed her so nicely, said she was the sweetest and the prettiest corpse they ever saw. My [blot] friends you may know I gave them a complete history of every thing that was done for her, and I think I can say sincerely that I never saw a sick person waited on so well and so cheerfully in all my life. It is a great consolation to us to know that Neppie dear lacked not attention and that she received it not merely because she was a sick child, but because she was beloved. Yes I do really think she had sincere [sic] to nurse her during her illness, and while I address you (dear four) I by no means forget the many many others who watched so faithfully by her bed-side. It is useless to mention each every name but well do I remember every one that came in her room during my short sad visit to Greensboro, and Oh! how I love them and how cheerfully would I prove my love should I ever find any of them in distress. God, bless and sustain in every condition of life each one of them from Mrs. BUMPASS, Mr. & Mrs. BETHEL down to the youngest person I saw and bless every one I know [sic] in Greensboro who manifested or felt the least interest in my dear Sister.

It is Tuesday now the same day of the week my poor Sister Neppie died. Oh & how sad to think of her as she looked then; my heart sinks within me and I feel like it is almost more than I can bear. God help me to bear it. I commenced this letter last Saturday but was too sick to finish it and to-day I don't feel even as well as I did then but must finish. My Sister (Mrs. SMITH from Johnston) reached home almost as soon as we did. She said she felt as if she never would see Neppie again when she first heard of her sickness. This seems to have been the impression made on each member of the family when told of Neppie's illness, though they durst not communicate it to each other. My father and mother and all the family request me to return their most sincere thanks to all of you for your great kindness to our beloved Neppie. May God bless you all with long and happy lives and at last the Crown of Life bestow[ed] is the fervent prayerof your Sincere friend, Eliza J. GREEN"

In reference to the above letter, Mr. Green supplied the following background information taken from family papers and cemetery records:

"Penelope (Neppie) Cain GREEN was born [in Franklin County, NC] at "Elm Grove" on 2 Dec. 1846. She was the youngest daughter of William Oscar GREEN (b. 31 Aug. 1805, d. 31 Oct. 1885) and Cynthia HARTSFIELD (b. 26 Oct. 1808, d. 19 Feb. 1890). Neppie died on 26 May 1863, while a student at Greensboro ... She was 17. Her father owned a 2,600 acres plantation, Elm Grove, located between Franklinton and Louisburg. Part of the original plantation is owned by members of the GREEN Family today...

Neppie was one of nine children. The author of the letter, Eliza Jane GREEN (b. 30 Apr. 1837, d. 21 Apr. 1922) married Capt. Julius Sidney JOYNER (b. 20 July 1839, d. 29 July 1892). Capt. JOYNER was Thomas Clingman JOYNER'S oldest brother ...

Neppie's oldest brother Col. William F. GREEN commanded the Franklin Rifles when they left for the great war on 20 May 1861. Col. GREEN was an attorney and represented his county in the Legislature for many years. His magnificant home, located a few miles from Elm Grove and called Paradise Lost from the death of his young wife, is in excellent condition ...

The Mrs. MITCHELL reference is another sister, Elizabeth Virginia GREEN (b. 6 Jan 1833, d. 24 Jun 1874), who married William H. MITCHELL. They lived at Portridge Plantation (located in the same area as is Elm Grove and Paradise Lost), and is the ancestral home of Osborn JEFFREYS... Neppie rests next to her parents and other family members at Portridge Cemetery. [Submitter's grandfather was Joseph Oscar GREEN, son of Neppie's brother Joseph Orlando GREEN. Joseph Oscar GREEN married Bessie Durham JOYNER, daughter of T. C. LYNCH.]

Thomas C. JOYNER; Margaret Camilla [LYNCH] JOYNER; Julius S. JOYNER; and Eliza J. [GREEN] JOYNER are all buried at the Joyner Plot, Fairview Cemetery in Franklinton."
