

Mr. R. T. Smith has sold his ---- prizery on New College Street to Miss Bettie Clark. The building will be altered ans improved and fitted up for use as a school. The location is a good one and the house admirably adapted to the purpose. Miss Clark has been successful here as an educator that her present quarters are not large enough for the accommodations of her pupils and it is her intention when she gets into her new building to add to her corp of assistants and make the course of instruction as thorough and complete as furnished by any institution in the state. Editor note: This school was known as the Hilliard School.

Obituary of Mark E. Parrott Oxford Torch Light February 23, 1886 Composed by his daughter Anna F. Parrott, twelve years of age

"The twenty fifth of June this last, My lovely father dear, Went home to live with God above, And we stayed sorrowing here

He was born in 1822 In fifty two he married, In eighty five he passed away, Oh! God he had tarried.

He had a wife, who mourns her loss, He had three children dear, Who knows he is with God above, but still are sorrowing here.

For thirty five or forty years He served his God above. He told his children to serve Him, and never cease to love.

He called unto his bedside there, His wife and children too, He said, "Oh, wife and children dear My thoughts are all of you.

> For I am not afraid to die I am going home to God. Am going home to live, the way our fathers trod.

He said, "When I am gone then sing, While ye stand around my bier, And know I am God above, And am not suffering here.

And every night before he slept, He knelt beside his bed, And prayed that those he might leave here, Would serve God when he was dead.

Thank God thar we have mother yet, God grant that she may linger, God may we love her in old age, The stronger and the stronger.

Let us love God with all our hearts, and lean upon his word, And after death we all may live Forever with the Lord.

Will of Travis Talley

In the name of God Amen, I Travis Talley of the county of Warren and State of North Carolina, being in good health and disposing mind, do on this 16th day of September in the year of our Lord 1847 make and ordain this my last will and testament.

Item 1st I give and bequeath to my beloved wife Sarah all my estate, both real, personal and perishable, to have and to hold the said property, during her life time or widowhood, however recommending to her the care and protection of my dear children, with the discretionary power of giving them off, such portion as in her judgment may be best for them, but in no wise to give them more than she may suppose would be more than their distributive share of my estate, and if my said wife thinks proper to marry, my will and desire is, that, my property as above named shall be equally divided between her and my surviving children and the heirs of such, as may die leaving children, and should she die without marrying my property will of course be equally divided among my children and their lawful heirs.

Item 2nd I do appoint my dear wife Sarah, my sole executrix to this my last will and testament -and declare this to be this my last will and testament by subscribe being my name thereto in presence of

To my son John Tally that part of my land beginning upon Allen Howard upper corner . . . corn the south side of the Cattaile . . . To my son Henery Tally that part of my land lying upon the south side of Deep Creek beginning at the mouth of Rockey run . . . to the mouth of the Beach Branch . . . also one young mare and a heifer of two year old. To my son Lodwick Tally that part of my land lying upon the mouth of Namassen Creek . . . to the back meadow branch . . . to the river . . . Also a young mare of four year old. Tally. Also unto Anna a wife all my personal estate during her life or widowhood and at her decease to be equally divided among all my children. Anna my loving wife executrix. Signed by John (I) Tally and witnessed by Seth More, Richard (R) Tally, and Philip (PD) Dunevant.21 Nov. 1740.

Presented by Ann Tally, executrix, and proved by Seth More and Richard Tally. Ann Tally refusing the burden of the execution, at the motion of William Tally certificate is granted him for obtaining letters of administration.

That is to say: 1st my desire is that all of my just debts be paid out of my estate

2nd I give and bequeath unto my beloved wife Elizabeth Burton the tract of land on which I live together with a lot which I bought of Phillip Moore Estate containing forty seven & a half acres adjoining the lands of the late Phillips Moore. Also five negroes (to wit) Lucy Humphery Sarah Ann Mosive & Joseph with their increases as of all of my perishable property with all monies bond and accounts due my estate not hereafter disposed of to have & to hold during her natural live & at her death desired to my daughter Drucill Etna Burton

3rd I give & bequeath to my oldest daughter Susan C. Reade wife of Washington F. Reade one negro girl Millie with her increases laso all of my interest in the lands or Mills owned by myself and brother Julius A. Burton. Said interest being one half also one hundred and six and eight tenth acres of land adjoining the lands of Thos. Sneed and Cameron it being a portion of this land known as the Sneed tract on Flat river the lines to be rn to as to include spring known as the Stephen Sneed spring which is the north end of said tract to be his and at disposal absolutely and forever

4th I give and bequeath to Washington F. Read one hundred acres of land adjoining the lands of Jas Cotham and Moses Chambers it being the south end corner of said land the lines to be run so as to include the place where Wm. A. Dixon lives it being a portion of the Sneed tract on Flat run in trust however for the benefit of my daughter Elizabeth Chambers wife of Benjamin Chambers during her nature life and at her death to divided to her children

5th I give and bequeath unto my daughter Drucilla Etna Burton four negroes (to wit) Douk Hawkins Annie and Henry with their increases to be at her disposal absolutely & forever

6th I give and bequeath to my nephew John A. Gooch one hundred acres of land it being south most corner of the Sneed tract on Flat River adjoining the lands of Thomas and Moses Chambers the lines to be run so as to include the old mansion House and spring to be his and at his disposal forever

7th and lastly I do herely appoint my truly friend Washington F. Reade and my beloved wife Elizabeth Burton my lawful executors & executrix to all intests & purposes to execute this my last will and testament to the true intent and manner os the same and every part and clause thereof hereby envoking and declaring utterly void all other wills and testaments by me heretofore made. In witness whereof I the said Thomas do hereunto set my hand and seal this 21st of July 1854.
