

From the President—

This summer has been a roller coaster ride for me. I was diagnosed with uterine cancer in March. Had surgery for this on June 12 and everything went fine after surgery. Duke Hospital removed the cancerous uterus. The best news was that I did not have to take chemotherapy or radiation. I learned something while a patient at Duke. There are sixteen different types of cancers. Duke has a window with a different color of ribbon for each one. They furnish ribbons for families and visitors to write messages on them and tie them to a rope. It was amazing to see how many had been tied to the rope. My last checkup was good news. I was moved from the cancer clinic to survivor clinic where I will be followed for five years.

While recouping from the surgery I was able to get back to my researching on the internet. I managed to find some more of my ancestors who served in the War Between the States. Also I found two whole branches of my family in Vance County, NC. I did not know this. So now I have been in touch with some of them through the internet. I am looking forward to meeting these relatives in person.

Ancestor Murdered

One of our members who lives in Oxford found a very interesting article in newspaper (The Spirit of the Age, Raleigh, North Carolina). Although this article was from Murfreesboro, NC it is about one of her ancestors.

Murfreesboro, NC Dec. 16, 1862

On Saturday 13th inst, Mr Joshua Ferguson, of this (Hertford) county, left his house, taking his little son along; he soon told the little fellow to return home and he went on. Mr. F. was not heard for some days, when his mutilated remains, partially charred were found near the cabin of a free negro named Artis. Artis was taken into custody and his wife and his father informed his captors, that Artis had murdered Mr. Ferguson, first striking him on the head with a hoe, afterwards chopped him to pieces with an axe and attempted to burn the body up. Being satisfied of the guilt of Artis, the incensed spectators immediately hung him. S. J. W.

An Interesting Obit

Published in the Oxford Public Ledger December 1909.

Old Uncle Billy Pettiford, a worthy colored man, who was greatly liked by whites and blacks alike, died last Monday morning about two o'clock, the immediate cause of his death being blood poison. The old man, who was 87 years of age, was very faithful to the Confederate service during the war, a fact of which he was always proud. He was carried to a number of the Confederate reunions where he was always welcomed. He served during the four years of struggle as cook and forager for the officers' mess, doing his duty well upon all occasions.

Uncle Billy, whose home was on Rural Route 7, near Mountain Creek Bridge, has been sick for about two months, and lately a scratch between his toes very greatly inflamed, causing the leg to burst open. The neighboring white people took pleasure in ministering to the worthy old man's needs, and he never suffered in his old age. Uncle Billy told Mr Josie Hunt several days ago that he would live but a few days and regretted that he never would see the new monument about which he had heard so much.

"SPELING DUSN'T COWNT"

Back in the day folks couldn't spell and many could barely write, so how a name sounds is more



important than how it's spelled. Use wild card or Soundex searches to help find variant spellings of names.

ASSUME NOTHING

Check all your facts, don't assume that any particular document is right or wrong, and always try to find other independent

sources to corroborate your facts as much as possible. Verify, verify, verify. For instance, don't assume that:

- your ancestors were married
- census information is accurate
- vital (or other) records were correct
- your ancestor's life events were recorded
- ancestors had the same name as their enslover

USE DISCRETION

Never lie in your genealogy reports, but use discretion when reporting family information, especially when it involves living

relatives.

ALWAYS DOCUMENT YOUR SOURCES, NO MATTER HOW MUCH



THEY CONTRADICT ONE ANOTHER Over time, you will compile more

data and those once seemingly contradictory pieces of evidence may prove to be just the pieces of the puzzle

you need to prove or disprove your theory. Be consistent as you cite your sources. There are standard citation formats, but



even if you just make up your own format for listing your sources, be consistent with it. You want your descendants to be able to retrace your steps, so you always cite your sources.

MOST DATES ARE APPROXIMATE

It's okay to state that someone was born "abt. 1845," or died "May 1915" if

you don't have an exact date or where various documents have

different dates. Which date is "correct?" They all are.

IF UNSURE, SAY SO

Future researchers will thank

you for being honest if you simply say that you cannot prove a specific fact, yet you "suspect"

such and such is true. Don't fudge the facts. Ever.

YOU CANNOT DO IT ALL ONLINE



Yes, we love doing research online and there's nothing better than using the computer to find new sources, view digital images of

original documents and even connect with relatives. For genealogists,



the internet will never replace the wonderful work of libraries, county courthouses, archives, and historical societies. Do as much as you can online,

then turn off your computer and hit the bricks!

JUST BECAUSE IT'S ONLINE DOESN'T MEAN IT'S TRUE

The internet is a wonderful thing but it's filled with oodles of bad information. Don't make the mistake of believing anything you find online at face value. Verify against other sources, even if you paid for the information you found online. Consult the original source whenever possible.


PASS ALONG YOUR RESEARCH

ANYTHING YOU POST ONLINE WILL **BE "BORROWED"**


You need to accept the fact that any family information you post online will be "borrowed" or outright stolen, and you will

Delayed Birth Certificates on file at the Register of Deeds Office in the Court House in Oxford, NC

Editors Note:

The delayed birth certificates were completed after 1913 when the law was added that everyone would have a birth certificate. These can be found for Granville County at the Register of Deeds Office in the Courthouse and at Vital Records Branch in Raleigh. To get a delayed birth certificate you had to show proof of either a Bible Record, school record, affidavit from a family member or other proof in order to get one. An example; my mother did not get one due to no parent living, no Bible Record, no date of birth on school record. The only proof was her word that she was born on March 7, 1896.

NOTES - This is the former location of the Dutchville Primitive Baptist Church. The church is long gone, but some concrete steps still remain on the property. The church was still active in the 1920s. The church was disbanded in 1960 and the land was returned to the heirs of the original donors. Sometime about 1976 the land and cemetery were purchased by Mary Green Chase and her husband Fred M. Chase. All of the property surrounding this cemetery is owned by Living Word Baptist Church which owns a new building on the property beside and behind the cemetery. Dear Geraldine, Edwin, and Rinard:

As I wrote your brother Lonnie recently, my grandmother, Arminta P. Green, was your great grandmother, your grandmother Lyon's , Kenneth Lyon's grandmother.

Arminta P. Green gave 2+ acres of land to the Dutchville Primitive Baptist witch disbanded in 1960 and the land that was given was returned to the heirs of the donors. However my sisters and I (the Green sisters originally, now all married) were the only ones who attempted to reclaim the land. (There had been three donors: Mrs A. P. Green, Mr John Adams, and Mr Robert L. Suit.) At the death of my grandmother, Arminta P. Green, my father, B. E. Green bought her estate from the other heirs. (He had already bought the land, the home place, sometime before.) "Aunt Minnie" "Sissie", Aunt Fannie, and Uncle Irvin Green, as well as your father, Kenneth and your Aunt Linda and Uncle Herbert, all had signed receipts, which we have, for a certain amount of money in exchange for their part of grandmother Green's estate. (The reason Herbert, Kenneth and cousin Linda signed these receipts and received the money was that their mother, Mary Green Lyon, had died at an early age, and her three children divided what would have been her share between them.) We assumed that my father's buying Grandmother Green's estate made him her only heir. In addition, we bought the land back from the church in 1967at a nominal amount. This would give us clear title, as we understood from our lawyer who drew the deed. However now there appears to be some doubt about this, and in order to be absolutely sure I am offering

I understand from Linda Lyon Woodall that Herbert's children will sign the quit claim deed and accept the ______ each. (Linda said they would do it for nothing, but we would not want that.) If you would like to do the same, please send me the name of your husband or wife, as in case may be, as it is necessary for both signatures to be on the deed and that the deed be signed before a notary publi0c. He would also need the name of the county you live in. In case any of you are divorced, or widowed, please add this after your name. I would plan to have three deeds, one for Herbert's, one for Kenneth's and one for Uncle Irwyn's, to sign

As soon as I have heard from you and have the above information, I will have your deed drawn and send it to you as promptly as possible with a check for each of you.

BLACK NORTH CAROLINA CONFEDERATE PENSIONERS

by Russell Scott Koonts North Carolina State Archives

[Editor's Introduction: In the vast literature regarding the Civil War, black men in Confederate service have received little attention. However, North Carolina records do identify some of those men.

In March 1927 the North Carolina General Assembly amended the statutes relative to Confederate Pensions and provided for payment of \$200.00 per year "to such colored servants who went with their masters to the war and can prove their service to the satisfaction of the county and State pension boards, ..." (*Public Laws of North Carolina, 1927, Chapter 96*) Applications for pensions came not only from wartime body servants, but also from those who had served Confederate forces as cooks, washers, laborers, teamsters, and constructors of breastworks. Most of these men had been slaves before the War, but there were some who had been free before Emancipation. The records below reveal a few black men who had actually enlisted in the Confederate Army.
